1. PARTICIPATING INSTITUTIONS

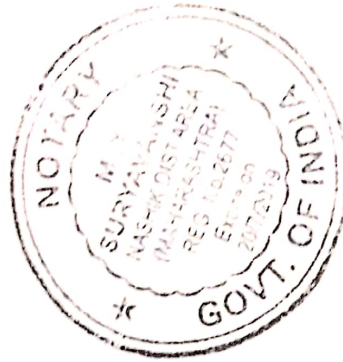
1.1 The parties intend by this MOU to establish a mutually beneficial partnership.

MEMORANDUM OF UNDERSTANDING (MOU)

Taking into consideration the repute of Ashwamedh Career Academy Pandit Colony Gangapur Road Nashik and MVP Samaj's the Arts and Commerce College, Nashik here after referred to as "the Parties", desire to promote and strengthen the existing friendly relations and co-operation between the two parties, and in particular in the fields so mentioned, have now reached the following understanding:

ON

• COOPERATION IN SPORTS FACILITIES & TRAINING

General Objective

This Memorandum of Understanding shall provide the frame work within which detailed proposals for programmes of co-operation between the Parties in the fields of sports and training are to be jointly considered on the basis of reciprocity and mutual benefit.

The parties shall endeavour to encourage and facilitate, as appropriate, the advancement of linkages and co-operation between and through the agencies that pertain to the fields of sports and shall endeavour to conclude such arrangements, for the conducting of cooperative activities and programmes in the concerned fields.

• Fields of Cooperation

In order to achieve the objectives of cooperation, in fields of sports and training, without limitation, the Parties shall encourage and promote exchange of programme, experiences, skills, techniques, information and knowledge, in the following matters:

- (a) Training and competition of Wrestling, Judo, Boxing, Gym. and athletic teams,
- (b) Exchange programmes and visits of sports leaders, sports administrators, professionals, technicians and sports support personnel,
- (c) Training, exchange and attachment programmes for sports and other development assistance in sports sciences,

- (d) Development of sports in college and competitions at Inter college level competition,
- (e) Any other fields or subjects as deemed to fit and necessary for the mutual benefit of the Parties, within the frame work provided under this Memorandum of Understanding.

• **Cooperation under this Memorandum of Understanding shall include, without limitation, the following:**

- (a) Exchange of information on sports development and training systems including information on sports and employment requirements & development in training;
- (b) Collaboration in the areas of sports.
- (c) Interaction through expert talks demonstrations and Seminars

In the event of a major illness, befalling on any of the players or members of a Party, during the period of a visit, the expenditure on medical treatment, shall be borne by the respective Party that sent such player (s) or member (s).

The parties will make arrangements for the implementation and development of specific programmes under this Memorandum of Understanding through meetings, exchanges of letters or other instruments. Each party will be responsible for coordinating the implementation of its side of plans/programmes. Such specific arrangements will cover the subject of cooperation, procedures, treatment of intellectual property, funding and other appropriate matters.

This Memorandum of Understanding may be amended by mutual consent in writing between the parties.

• **Settlement of Disputes**

Any dispute between the two parties arising out of the interpretation or implementation of this Memorandum of Understanding will be settled amicably by mutual consultation and negotiation.

The Collaborative work between Ashwamedh Career Academy Pandit colony Gangapur road Nashik. and MVP'S the Arts and Commerce College, Satpur Nashik. is in existence since the 2 years. In order to make it more authentic and comprehensive the same document is being converted into a Memorandum of Understanding. in the presence of a Notary from the present academic year.


This Memorandum of Understanding will come into effect on the date of its signing. It will remain in effect for a period of five (5) years. Upon its expiry, the Memorandum of Understanding may be renewed for successive periods of five (5) years by mutual consent. The Memorandum of Understanding may be terminated by either party by giving six months written notice to the other party. If this Memorandum of Understanding is terminated, any arrangements concluded under it will, subject to the mutual determination of both the Parties, remain effective until any activities pursuant to such arrangements have been carried out to their completion.

This MOU does not include the exchange of funds between the two parties as per UGC Rules the remuneration will be paid to the faculty /staff of the college partner for teaching.

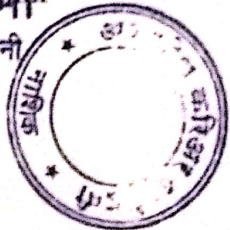

This Memorandum of Understanding entered into the 6th day of December, 2017,

Objective:

The objective of this MOU is for Naandi Foundation –Mahindra Pride Classrooms (Naandi) to impart skill based training to the Final Year students of **MVP Samaj Arts & Commerce College** as part of their **Employability Enhancement Skilling (EES)** program, a CSR initiative of the Mahindra & Mahindra group.

The training will be **MVP Samaj Arts & Commerce College**, based on the following terms and conditions:-

Terms and Conditions:

- a.) Naandi will train the Final year students of your college in the EES program as per the indicative framework attached.
- b.) The number of students trained in your college would depend on the availability pool in your college. We can do multiple batches of 50 students each. Preference will be given to students who want to take up employment after they graduate.
- c.) Your college will assign a coordinator for this project who will engage with the coordinator of Naandi.
- d.) The program will be for 20 days -40 Hours during college timings, in the college premises as part of the timetable.
- e.) Trainers will be deployed by Naandi Foundation for each location depending on the number of batches. Daily attendance will be administered and the same shall be furnished to the colleges.

- f.) Classes shall be conducted within the college premises either in class rooms or in the Soft Skills lab.
- g.) A timetable will be prepared in consultation with the college.
- h.) Naandi wishes to start training in your Institute on 6th December 2017 at a mutually convenient date.
- i.) Naandi is open to doing multiple batches in phases based on the timings and availability of the students of the college.
- j.) Naandi Foundation shall conduct the training entirely free of charge as part of CSR from the Mahindra & Mahindra Group through their Mahindra Pride Classroom project.
- k.) The college will provide the premises, computer labs, electricity, LCD projectors, stationery, copies of study material and other standard infrastructure.
- l.) The college must also give us all the data of the students who attend the training. Their contact details and placement details in the formats provided by us.


